Silver Spur Trade Shows, Inc. ("SSTS") wants to sponsor a show that is safe and legal, to display and sell firearms and the like. All Exhibitors exhibiting at the shows sponsored by SSTS are required to abide by all local, state and federal laws and regulations. All Exhibitors are responsible for their own merchandise, employees and customers during show hours; after hours SSTS provides inside security. Subletting of tables is restricted without written permission from show management.

In addition to the Guidelines above, Exhibitors are also required to:

1. Exhibitor(s) will keep all guns tied in such a manner as to make them inoperable. If a tie is cut to look at gun, check and retie immediately.
2. No loaded guns at any time, under any circumstances, are allowed at the shows.
3. Exhibitor(s) will keep all ammunition sealed at all times in boxes or bags, no loose ammunition is allowed on display tables.
4. No loaded magazines.
5. If you take a gun in on trade, please re-check and re-strap the weapon.
6. Be respectful of all Exhibitors, Customers, and show directors, representatives and employees.

SSTS show director and/or employees may ask violators of these Guidelines to leave the show without refund or argument. Exhibitors will be further banned from any future SSTS shows if a 1)weapon in your possession is discharged, 2)for not following the Guidelines or 3)for theft.

I understand by signing this document that I have entered into a binding, written agreement for myself and as the Exhibitor, whereby we agree to abide by the show's rules and all Guidelines herein. We understand that we are responsible for all tables and spaces in said Exhibitor's name, and will not hold Silver Spur Trade Shows Inc. responsible for myself or the Exhibitor's property. By signing below, each such Exhibitor hereby agrees to **indemnify and hold harmless** SSTS and its owners, officers, employees or agents from any and all claims, causes of action or for damages of any type or character, whether in law or equity, and for all attorney fees and costs related thereto, for conduct or actions Exhibitor, its employees, its owners, officers, employees, agents and/or customers may do or fail to do. This **indemnification and hold harmless provision** includes any and all such claims made against SSTS by other Exhibitors, third parties, customers, show participants, or any other party or entity attending or related to the show in any way. In the event it shall become necessary for SSTS to employ an attorney to defend against any lawsuit or claim due to any action caused either directly or indirectly by the Exhibitor(s) and/or Exhibitor's staff, agents, employees, and/or family, the Exhibitor agrees to pay for all costs incurred from such lawsuits, legal proceedings or claims, including reasonable attorney's fees.

SSTS reserves the right to refuse admission to any Exhibitor(s), at any time, including asking said Exhibitor to leave the show. If, by the independent determination of SSTS, it is determined that any Exhibitor(s) is/are not following these Guidelines, and/or not engaging in commercially reasonable standards with regard to the sale of any products at the show, or other improper activities at the show, the Exhibitor(s) will forfeit table rental fees and be subject to immediate removal, suspension and/or permanent expulsion from the show, and participation in any or all future shows with SSTS.

SSTS reserves the right to amend the "Guidelines & Agreement" without prior written notice. This agreement is intended to be valid indefinitely.

Sales tax revenues are the sole responsibility of the exhibitor/vendor.

Cancellation Policy - 10 days or more before show you can get a full refund or apply to another show. 10 days or LESS prior to show, no refund and cannot apply to another show, may have chance of losing your assigned space(s).
